### 4. First-aid measures

## 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

Stop the flow of material, if this is without risk.

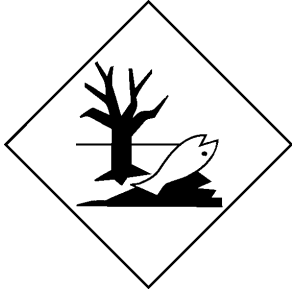
